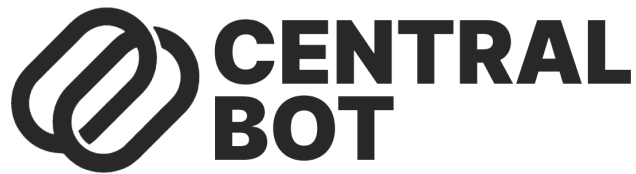


Central Bot - Terms of Service

Terms of Service

1. Definitions

- “**Central**”, “**we**”, “**our**” and “**us**” – The community behind the development of centralbot.xyz or an affiliated service (such as “**the Bot**” or any entity under our brand).
- “**Bot**” – An asset provided under the Discord platform, managed as a third-party application.
- “**Website**” – Any and all assets under the domains listed below.

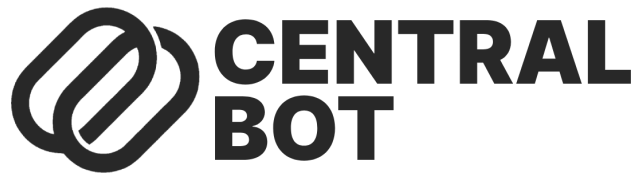
2. Acceptance of Terms

By accessing or using the Central Bot (“**the Bot**”), the Central Website (“**the Website**”), or any affiliated brand services, you confirm that you understand, accept, and agree to be bound by the terms set forth in this document.

3. License to Use

We grant users and Discord servers (“**Guilds**”) a limited, revocable, non-exclusive, and non-transferable license to use the Central Bot and Website for Discord-related operations. This license is subject to the following conditions:

- The **Bot** and **Website** may not be used for any unlawful or unauthorized purpose, including (but not limited to) the distribution of illegal content, controlled substances, exploitation, or fraudulent activities.
- You may not attempt to decompile, reverse engineer, or otherwise access the source code of the **Bot** or **Website**.
- You may not use the **Bot** to harass, abuse, exploit, or harm other users or communities.
- You may not exploit the **Bot** or **Website** for commercial purposes without our explicit written consent.
- All restrictions outlined under **Section 6 (Prohibited Actions)** also apply.



4. Data Collection and Privacy

To provide essential services and functionality, the **Bot** and **Website** collect and store limited data, including but not limited to:

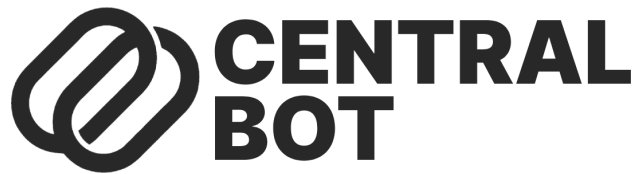
- Server configuration data
- User account information and management data
- Command usage statistics
- User interaction logs
- Moderation records
- Module-specific data

By using our services, you consent to this collection and acknowledge that while we make reasonable efforts to protect user data, we cannot guarantee absolute security against unauthorized access. For additional details, please review our [Privacy Policy](#).

5. Premium Services

We may offer paid premium features (“**Premium**”) that grant enhanced functionality within the Bot. By purchasing or using Premium services, you agree to the following terms:

- Premium features must be used in compliance with these Terms of Service.
- Access to Premium features may be modified, suspended, or revoked at our sole discretion without liability.
- All Premium payments are **non-refundable**, except in cases where confirmed technical issues prevent expected functionality. Refund requests are subject to review and approval at our discretion. This review is final and not subject to dispute.
- We may alter the scope, pricing, or availability of Premium features at any time without prior notice.



6. Prohibited Actions

While using the Bot or Website, you agree not to engage in any of the following activities:

- Exploiting known or unknown bugs, vulnerabilities, or glitches in order to gain unfair advantage or disrupt service.
- Redistributing, reselling, or otherwise commercially exploiting Premium features without our explicit written authorization.
- Using the Bot to interfere with or circumvent Discord server moderation systems.
- Distributing false, misleading, or harmful content through the Bot, including scams, phishing attempts, or deceptive giveaways.
- Accessing or attempting to use the services if you are under the minimum age of 13, or under the minimum age of digital consent in your jurisdiction (whichever is higher).

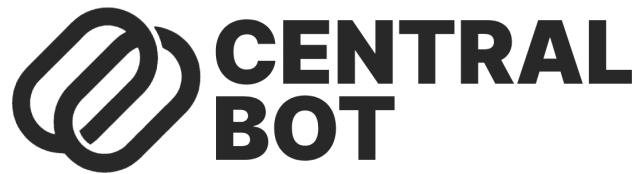
Violations of this section may result in immediate suspension or permanent termination of your access to the **Bot** and/or **Website**.

7. Limitations of Liability

To the maximum extent permitted by law, Central and its affiliates shall not be held liable for any direct, indirect, incidental, consequential, or punitive damages arising from or related to:

- The use of, or inability to use, the **Bot** or **Website**.
- Unauthorized access to, alteration of, or loss of user data.
- The actions, statements, or conduct of third parties using the **Bot**.
- The outcome of user-operated giveaways, promotions, or events, including unfulfilled prizes or disputes.
- Any other actions not explicitly carried out by confirmed Development or Management members of the Central Team.

You acknowledge that the services are provided “**as-is**” and “**as-available**”, without any warranties or guarantees of availability, reliability, or fitness for a particular purpose.



8. Service Modifications

We reserve the right, at any time and without prior notice, to:

- Update or amend these Terms of Service.
- Adjust the pricing or scope of Premium services.
- Add, alter, or remove features, modules, or integrations.

9. Termination

We may suspend or permanently terminate your access to the **Bot** or **Website**, with or without prior notice, for any reason (or no reason), including but not limited to:

- Violation of these Terms of Service.
- Abuse or misuse of the **Bot** or **Website**.
- Fraudulent, illegal, or harmful activity.
- Activities that disrupt or interfere with the operation of our services (e.g., raiding).
- Violations of Discord's Terms of Service or Community Guidelines.

Termination decisions are final. However, users may contact our support team if they believe a suspension or termination was issued in error.
